TERMS OF SERVICE

VOIPSCAN LIMITED, a legal entity organised and existing under the laws of Cyprus Republic, with the address: Patron, 10, 6051, Larnaca, Cyprus, Certificate of Incorporation dated 6 of April 2016 number HE 354242 (hereinafter called as the “VOIPSCAN”).

VOIPSCAN makes available for your use on its websites ("Website" or "Site") information, documents, software and products (collectively "Materials") and various services offered by VOIPSCAN (collectively "Services") subject to the terms and conditions set forth in this document ("Terms of Service"). By accessing or using this Site, which includes your access to or use of any Materials or Services, you agree to be bound by these Terms of Service. If you do not wish to be bound by these Terms of Service, you may not access or use the Site, Materials, or any of the Services. By using the Materials or Service, you are agreeing to be bound by these Terms of Service.

VOIPSCAN may modify the Materials, Services and Terms of Service at any time without notice and such modifications shall be deemed effective immediately upon making such changes. Additionally, when using particular Services or Materials, you shall be subject to all posted agreements, guidelines or rules applicable to such Services or Materials that may contain terms and conditions in addition to those in the Terms of Service. All such guidelines or rules are hereby incorporated by reference into the Terms of Service.

THE SERVICES

ACCOUNT REGISTRATION

The Customer agree to provide true, accurate, current and complete information in all fields indicated as mandatory when registering for the VOIPSCAN Services, as well as any additional information provided or any amendments made by you. As part of signing up on the Site you will choose a password required for access to and use of the VOIPSCAN Services. You are responsible for all actions that take place as a result of access to or use of the VOIPSCAN Services via your password and/or via your phone (“Device”) independently of whether the access was made by yourself or by a third party using your password and/or Device.

PHONE NUMBERS PROVIDED BY VOIPSCAN

All phone numbers provided for use are unique for each active account and cannot be used by another active account. You expressly acknowledge and agree that the assigned numbers are not portable to any third party.

ACCOUNT NUMBER, PASSWORD AND PERSONAL IDENTIFICATION NUMBER (PIN)

You are responsible for maintaining the confidentiality of your account number and password. You are responsible for all uses of your account, whether or not actually or expressly authorized by you.

DISCLOSURE OF INFORMATION

VOIPSCAN reserves the right at all times to disclose any information as VOIPSCAN deems necessary to satisfy any applicable law, regulation, legal process or governmental request, or to edit, refuse to post or to remove or restrict any information or materials, in whole or in part, in VOIPSCAN's sole

discretion.

UNAUTHORIZED USE/STOLEN DEVICE

If your Device is stolen or if you become aware of unauthorized use of the VOIPSCAN Services you must notify us immediately to suspend the VOIPSCAN Services. You are responsible for all charges to your account with VOIPSCAN (“Account”) until the VOIPSCAN Services are suspended. We have the right to change your password and user name at any time in our sole discretion and without notice.

NO EMERGENCY CALLS

The VOIPSCAN Services do not and are not intended to support or carry emergency calls to any type of hospitals, law enforcement agencies; medical care unit or any type of emergency services of any kind and VOIPSCAN is not liable in any manner for such calls. In the event that, with your permission, another user uses your Account, you are responsible to inform that user that it is not possible to support or carry emergency calls with the VOIPSCAN Services.

NO UNLAWFULL OR PROHIBITED USE

You expressly acknowledge and agree to use any VOIPSCAN Service solely for lawful purposes. In this respect you may not, without limitation (a) intercept or monitor, damage or modify any communication which is not intended for you, (b) send any unsolicited commercial communication, (c) use any VOIPSCAN Service in any fraudulent way, (d) submit or post to the Site or expose any third party to material which infringe any third party’s intellectual property rights or violate the rights of any third party, is offensive, defamatory, racist, pornographic, illegal, harmful to minors, indecent or otherwise, in VOIPSCAN’s sole discretion, is objectionable. Furthermore, you may not submit or publish any material that solicit funds or services, contain advertising or include programs that contain viruses or any other programs designed to impair the functionality of any computer and you may not use any VOIPSCAN Service in any manner that could damage, disable, overburden, or impair any VOIPSCAN server, or the network(s) connected to any VOIPSCAN server, or interfere with any other party's use and enjoyment of the VOIPSCAN Services.

NO WARRANTIES

VOIPSCAN does not make any express warranty regarding the VOIPSCAN Services and disclaim any implied warranty, including any warranty of merchantability, satisfactory quality, or fitness for a particular purpose; however VOIPSCAN shall endeavor to provide the VOIPSCAN Services with minimum disruptions. VOIPSCAN cannot guarantee that the VOIPSCAN Services will always function without disruptions, delay or other imperfections and VOIPSCAN may choose not to provide service to countries or calling areas at its sole discretion. Since the VOIPSCAN Services will be transmitted through public Internet lines and the public switched telephone network, you acknowledge that there may be power outages or Internet service disruption and you may experience some disruptions in the VOIPSCAN Services. Additionally, you also understand that calls, SMS, etc. to or from the public switched telephone network are not encrypted and as such, could be potentially subject to eavesdropping by law enforcement officials or other third parties over the public Internet. VOIPSCAN will not be liable for any disruption, delays, eavesdropping or other omissions in the VOIPSCAN Services.

CUSTOMER SERVICE AND SUPPORT

To keep VOIPSCAN operating cost low and pass the savings to our customers we offer support via emails only. We will make our best effort to answer emails immediately but in some cases response

may take up to 24 hours.

PAYMENTS AND RATES

Call times for each call are rounded up to the next whole minute and billed in full minute increments. All calls for which we receive answer supervision shall incur a minimum one-minute charge. VOIPSCAN relies on answer supervision to determine whether and when a call has been answered. Answer supervision is a signal sent by the carrier connecting the call to indicate the start of call. Answer supervision is generally received when a call is answered; however, answer supervision may also be generated by voicemail systems, private branch exchanges, and interexchange switching equipment. All the assets added by the Customer of the VOIPSCAN to his personal account can be used by such customer all the time his activity of the Service. At that, in case of the Customer's account is closed all the funds and assets located into the Customer's account shall be transferred to the Customer accordingly his banking requisites.

BILLING DISPUTES AND ACCOUNTING ERRORS

The Customer must notify us in writing of any disputed charges within thirty (30) days of the charges or you will have waived your right to dispute the charges.

APPLICATION OF PAYMENTS AND CREDITS

When a call is charged against your account, we will first charge against all available credits purchased by your credit, debit or charge card. Once such credits are depleted, we will charge against any available bonus, promotional or other credits in your account.

REFUND POLICY

The Customer may request for a refund his funds or assets by contacting VOIPSCAN's customer services via info@voipscan.eu. Refund requests carried out through other means shall not be eligible for the refund. No refunds will be given for services paid or credit acquired through referral bonus, deposit bonus, promotional gift euro awards, or any other award bonuses. VOIPSCAN shall be obliged to refund to a customer his funds. Any abuse by you of the terms relating to refunds hereunder shall lead to the termination of this Terms of Service.

DISPUTES CHARGES AND COMPLAINTS: If the Customer, in good faith, disputes the amount of any charge included in balance in the personal account, such Customer must notify VOIPSCAN in writing of the disputed charge within thirty (30) days of the date of such misunderstandings and provide documentation reasonably required to resolve the dispute. Failure to contest a charge within thirty (30) days of the date of the such misunderstandings will create an irrefutable presumption of the correctness of the charge and the Customer shall have waived its right to dispute that charge. In addition, for prepaying Customers, if payment is made via credit card, any credits or refund made to Customer's account must have VOIPSCAN'S written authorization.

TERMINATION AND CANCELLATION

SUSPENSION AND INTERRUPTION

VOIPSCAN is entitled, without any liability, to refuse, restrict, limit, suspend and/or interfere or interrupt the VOIPSCAN Services or any part thereof, without any notice to you for the repair,

improvement, and/or upgrade of the VOIPSCAN Services or for any of the reasons for termination set forth below in these Terms of Service. In addition, at any time VOIPSCAN may prevent use of the VOIPSCAN Services for any reason, including but not limited to, fraudulent calling patterns, excessive usage, billing irregularities and unlawful use.

CANCELATION

You may discontinue using the Services at any time by notifying us by e-mail (info@voipscan.eu). We will terminate your Account as soon as practicable; in all cases, you will remain responsible for payment of all charges for Services rendered up through such termination.

EXPIRATION POLICY

Account expires and will be closed after six (6) months of inactivity (measured from the date of last use). If you desire to keep your Account active, you may request an extension of the expiration period by notifying us by e-mail (info@voipscan.eu). Upon receipt of your request, we may, at our sole discretion, provide you with an extension of the expiration date of your Account. All extensions will be confirmed by us via e-mail.

TRADEMARKS
